
# Head Start Annual Report

## Budgetary Expenditures and Proposed Budget




The chart shows the percentage of achievement for all children in the Head Start domains according to the Galileo Assessment for the 2023 - 2024 school year. It also showcases the growth percentage among all children during the assessment timeframe.

**Program Performance Summary** 

In January of 2024, the Office of Head Start conducted a Federal Monitoring Review. The program was evaluated using the Head Start Program Performance standards, a complex 160-page document and a 126-question fiscal review. After a week of reviewing performance, the program was cited for only two non-compliances, which were corrected and submitted for total compliance. The program scored a Strong Practice in staffing and staff supports.


In March of 2024 the program received the second half of the Federal Monitoring Review by submitting hour long videos of each classroom while in session. Using the C.L.A.S.S. scoring tool, Federal contractors scored the classrooms on Emotional Support, Classroom Organization and Instructional Support. Kno Ho Co Ashland CAC Head Start did very well.

#### **Federal Enrollment Initiative**

Head Start Requires that program serve their entire allotment of funded children. Kno Ho Co Ashland CAC head Start was funded to serve 321 children. Due to economic changes in the services area and the unchanging income guidelines for eligibility at 100% of poverty, the program was unable to fill all slots with income eligible children. The program requested an enrollment reduction to 210 children in fall of 2023. Before the reduction was approved, the program was required to be put on a Federal Enrollment Initiative (FEI) plan in November of 2023. Since being approved for the reduction at the end of December 2023, the program has been able to remain fully enrolled. However, the plan remains in effect for one year.
